

ACHIEVEMENT OF CID-CB ODISHA FOR THE YEAR 2018

A) CRIME BRANCH

1) **Investigation** :-CID Police Station took up investigation of 33 cases against 20 cases taken in 2017. So far CID CB has submitted Final Form in 35 cases in this year.

Cyber PS of CID-CB took up investigation of 22 cases in 2018. Cyber PS of CID CB has finalized investigation in 18 cases so far and has arrested 17 culprits including foreigners from Delhi.

2) DETECTION OF IMPORTANT CASES :-

a) A sensational Patnagarh Parcel Bomb case.ePatnagarh P.S Case No.35/18, dtd.23.02.18 was taken up investigation by CID-CB vide CID PS Case No.7/18. Due to prompt investigation, this unknown case could be detected and charge sheet has been submitted against concerned accused. Detection of this case has been highly appreciated by the public.

b) Conviction of sensational kidnapping case with murder i.e CID CB Case NO.54/12. Hon'ble ADJ Chhatrapur has convicted 3 accused persons by sentencing for life imprisonments. Case was investigated by STF.

3) EMPHASIS ON SPEEDY INVESTIGATION/PROSECUTION

OF RED FLAG CASES:-

a)Sensational rape cases, gang rape cases and rape case against minors have been treated as "**Red Flag Case**" and monitored from CID CB by pursuing effective prosecution through engagement of Spl. PPs. Due to effective monitoring, the conviction in Red Flag cases has gone up to 43.1% in 2018. (as per database of Judgement copies received in CID CB). Besides, Red Flag cases, instructions have been issued to district SsP in other rape cases for successful investigation.

b)CID CB has issued illustrative instructions to Dist SsP in important murder (122),rape (377),Dacoity (663) cases for successful investigation.(till Nov)

4) COUNSELLING OF WOMEN/CHILDREN:-

Earlier, 9 numbers of Family Counseling Centre/Women Support Centres were operating in collaboration with district police. During 2018, 7 number of new FCC/WSCs have been opened up at district police offices to mitigate the grievance of distressed families, particularly women.

5) **Opening of 3 new Cyber PsS** at Berhampur, Rourkela and Sambalpur.

6) APPOINTMENT OF LEGAL ADVISERS:-

15 numbers of Legal Advisers have already been appointed in 2018 as against sanction of 24, who will be assisting district SsP for effective prosecution/investigation at all stages till completion of trial.

7) MOTIVATION TO IOs/PPs:

For the 1st time, State Police has started felicitating successful investigating officers and Public Prosecutors for fetching convictions. A workshop was also been conducted for all Public Prosecutors/Addl. PPs for streamlining of prosecution of important cases which are pending trial.

8) ROAD SAFETY MEASURES:-

a) Earlier, Student Traffic Volunteer Scheme was in operation in Twin Cities of Bhubaneswar-Cuttack. It was extended to 4 more towns i.e Sambalpur, Rourkela, Berhampur and Balasore in 2018.

Due to pro-active approach of CID-CB, Govt. has been pleased to enhance it to 6 more towns from 1.1.2019. (Koraput, Angul, Dhenkanal, Keonjhar, Puri and Khurda)

b) A comprehensive plan has been submitted about Highway Patrolling for accident-prone Highways.

c) Workshops have been conducted for district police officers about use of breath analyzers and e-challan machines. Transport Commissioner has agreed to provide 50 nos. of e-challan machines very soon to district police.

d) Due to our proposal, Govt. has been pleased to confer powers of compounding under MV Act to rural PSs.

e) Rs12.32 Crores of revenue for the State exchequer has been generated by the State Police during April-October, 2018.

f) Proposal for various road safety equipments and other measures has been submitted to Transport Commissioner.

9) CYBER CRIME FORENSIC LABORATORY CUM-TRAINING CENTRE :- Steps have been initiated for purchase of equipment under CCPWC Scheme.

10) LINK TO CYBER CRIME PORTAL:-

As per direction of Hon'ble Supreme Court, complaints from public on cyber crimes relating to child pornography and rape/gang rape can be lodged directly online. Cyber PS is monitoring the complaints as and when received.

11) SKILL DEVELOPMENTS & WORKSHOPS

Various types of workshops have been organized by CID, CB:-

a) With bankers on security related issues of Banks/ ATMs.

b) With Police Officers on investigation of POSCO cases, functioning of IUCAW/ IAHTU.

- c) Workshop on investigation of OPID Act cases in collaboration with RBI,SEBI and ROC etc.
- d) Awareness of Police Officers about use of Breath Analyzers and e-Challan machines.
- e) Seminar on forensic accounting for EOW/ STF Officers.
- f) Joint strategy/ workshop for destruction of Cannabis Plants and detection of NDPS cases.

12) **ISSUE OF ADVISORY / CIRCULAR / JUDGEMENT COPIES:-**

Large number of Advisory/ Circular have been issued to district SsP on various burning subjects of the Society. Some notable Circulars are enumerated herewith.

- Issued Police Circular Order No-374/2018 dtd 25.01.2018 and 377/2018 dtd 13.8.2018
- Issued Advisory on Criminal activities among students in educational institutions and prevention thereof.
- Issued Advisory on letter/Parcel bombs through Courier/Post.
- Issued Advisory against rumours on Child lifters.
- Issued Advisory against mob leaders for damage to public property.
- Issued Advisory on use of fire cracker during festive occasion.
- Issued CB Circular No-1/2018 on 29.3.2018, CB Circular No-3/2018 on 25.4.2018, CB Circular No-4/2018 on 16.5.2018, CB Circular No-5/2018 on 11.6.2018 on various aspects pertaining to police investigation techniques/tools etc.

13) **Uploading of important judgments :-**

- a) : - CID, CB has uploaded promptly all important land mark judgments of Hon'ble Apex Court for speediest implementation.
- b) Witness Protection Scheme as enumerated by Hon'ble Apex Court on 05.12.18 has been communicated to all SsP on 06.12.2018.
- c) Orders of Hon'ble Apex Court against victims giving false evidence in rape case has also been uploaded in website.
- d) Latest victim compensation scheme of Govt. has been uploaded for benefit of the public.
- e) **Landmark judgment of Hon'ble Apex Court for taking action against mob leaders for damaging public properties.**

Above judgment of Hon'ble Apex Court has been uploaded by CID, CB & follow up action has also been initiated against mob leaders by moving to Hon'ble High Court Registry, as per guidelines prescribed in the judgment.

14) Operation Paree

Odisha Police in technical collaboration with UNICEF has organised a campaign titled “**PAREE PAIEN KATHATIYE**” from 28.05.2018 to 12.06.2018 to sensitize the general public against sexual harassment on minor girl. **15** vehicles decorated as “**PAREE EXPRESS**” moved throughout the State for a period of 15 days covering distance of more than **44707 kms**. During the campaign **1377 venues** were covered and at about **12 lakh** people participated. Different stake holders, people representatives and PRI members were also attended the awareness campaign.

“Operation Paree II” was launched for rescue/tracing of missing children/child labour. All total **2789 (Boy- 2284 & Girl-505)** children were rescued from different places inside the state and total **106 (Boy- 61 & Girl-45)** were rescued from outside state.

15) STARTING OF E-DESPATCH IN CID, CB:

16) CREATION OF DATABASE OF INTER-STATE AND INTER-DISTRICT CRIMINAL GANGS.

For the first time, a database of hard core M.O. criminals has been created in CIG Section.

17) STRENGTHENING OF CANINE SQUAD:-

9 numbers of pups have been added during the year 2018 to Canine Squad of State Police for assisting Police investigation.

18) DISPOSAL BY HANDWRITING BUREAU:-

State Handwriting Bureau has examined 195 cases till November in this year.

(B) S.T.F:-

1. STF has taken up **22** cases for investigation in 2018 against **6** (six) cases of 2017.

As Specialized Wing for investigation of Wild Life Crimes, STF has taken up **7** (Seven) cases and arrested **18** accused persons.

2. As Nodal Agency for enforcement of action against **Organized Crimes/ Syndicates**, STF has registered **8** number of cases out of which **5**(five) cases have been registered against Gangstar Tito @ Sahyd Usman Alli and his associates. During investigation, Tito alongwith his **17** associates have been arrested along with recovery of 3 nos. of firearms and 21 nos. of vehicles.
3. As Nodal Agency for enforcement of **Narcotics**, STF has monitored destruction of Cannabis Plants by giving targets for joint enforcement by the concerned agencies. During the ongoing crop year 2018-19 , destruction of Cannabis Plants has been done

in **6683.24** acres of land against target of **5310** acres. **76** (seventy six) numbers of cases have been registered against illicit cultivation of Cannabis Plants.

4. During Jan-Nov-2018 ,record amount of Ganja of **704** Quintals & **989** gms Brown Sugar has been seized by State Police along with seizure of **12.19** lakhs Cash & **131** vehicles. This is an all time high record.

(C) E.O.W:-

1. EOW has registered **28** (twenty eight) number of cases so far against **26**(twenty six) of 2017. During 2018, EOW has finalized investigation of 46 cases and has arrested 103 numbers of accused persons against 74 (seventy four) arrested during 2017. EOW has submitted ad interim proposals in 16 cases under **OPID Act** for attachment/ confiscation proceedings of properties.
