Sub: Guidelines to be followed by the Investigating Unit for Crime Against Women (IUCAW) while investigating sensitive cases.

As per the guidelines IUCAW units may be utilized to investigate into sensitive cases under POCSO Act, Murder, Dacoity, kidnapping, Cyber Crime and serious economic offences. During investigation the guidelines to be followed by the IUCAW as per Notification. The Notification is available in the website www.odishapolicecidcb.gov.in.

It is therefore, requested to download the notification and issue suitable instructions to the officers attached to IUCAW to implement the guidelines strictly.

In view of establishment of twenty nine (29) specialized Investigating Units for Crime Against Women, by virtue of the notification No.22404 dated.07.07.2015 and No.11693 dated.27.03.2017 issued by the Home Department, It is expedient in the interest of criminal Justices that the services of the specialized IUCAW may also be utilized to investigate into other sensitive cases relating to the commission of offences under POCSO Act, Murder, Dacoity, Kidnapping, Cyber Crime and serious economic offences etc., as to be decided from time to time under the direct supervision of the Superintendent of police/ D.C.P of the district concerned. The units so formed shall function as District Investigation Units to investigate sensitive cases so defined/declared.

The following guidelines are to be followed by the IUCAW while investigating the sensitive cases/offences.

- (1) On receipt of information relating to registration of sensitive cases by the Superintendent of police/D.C.P from officer in-charge of the police station, he shall pass necessary orders to the head of the IUCAW of the district either himself to take up the investigation of the sensitive case or depute an investigating officer or team of officer(s) to take up investigation.
- (2) The head of the IUCAW of the District on receipt of the requisition from the Superintendent of the Police/DCP depute the Investigating Officer/team of Officers as the case may be for investigation of sensitive cases.
- (3) The officer in-charge of the concerned police station shall render necessary assistance/co-operation to the investigating officer/officers for proper investigation and to complete the same in time.
- (4) The head of the IUCAW of the district may direct further investigation, if necessitated after recording reasons thereof, by other an investigating officer or team of officers. After completion of investigation the IO who completes the investigation shall submit the final report to the superintendent Police/DCP who in turn shall direct the concerned officer to submit the final form in court of law.



(5) One inspector and one constable of IUCAW may be specifically entrusted to the task of monitoring of the trial of the sensitive case/cases. They shall keep close liaison with the prosecutors, Forensic Science Laboratories and Court Sub-inspectors for timely submission of required reports, attendance of IOs and witnesses, keep such database for attaining successful prosecution.

(6) Biju Patnaik State Police Academy shall impart training on domain areas like Juvenile Justice, Cyber Crime, Economic Offence etc.
