There shall be Juvenile/Child Welfare Officers in all Police Stations as required under sub-section (1) of section 107 of the Juvenile Justice (Care and Protection of Children) Act, 2015 (hereinafter referred to as "the Act"). The Mahila Sishu Desk Officers of the general police stations of the State coming within the jurisdiction of the concerned districts shall act as Juvenile/Child Welfare Police Officers as required under the above cited Act.

This order will come into force with immediate effect and supersedes the Notification No. 37757 Dated 24th September 2012 and No. 37761 Dated 24th September 2012 of this Department.
