In pursuance of the direction dated 05th December, 2018 of Hon'ble Supreme Court of India passed in Writ Petition (Crl) No. 156 of 2016 filed by Mahender Chawla and Others Vrs Union of India and Others, and Home Department Notification No. 26424 Dated 05th July, 2019, a Standing Committee is hereby constituted in each district of Odisha with the following:

1. District and Sessions Judge .....Chairman
2. Superintendent of Police.....Member
3. Senior Most Cadre Prosecutor.....Member Secretary


The Standing Committee shall pass the Witness Protection Order within five days of receipt of the witness protection application, duly moved by the witness, his family members, duly engaged counsel or IO/IIC/OIC/SDPO/ Jail Superintendent through the public prosecutor concerned. The application shall include threat analysis report of police authorities. The Witness Protection order shall detail the witness protection measures including protection of identity or parentage or occupation or address or digital footprints of witness as well as relocation to a safer place within the State or Territory of the Indian Union keeping in view her/his safety, welfare and well being. The Standing Committee shall also monitor its implementation of the Witness Protection Order(WPOs) and review the same on quarterly basis in terms of monthly follow up reports received from the Witness Protection Cell.
