Effective pursuance of follow up action in heinous cases like organized gangs (Contract Killing), offences against Women etc.

Few instances of inadequate/improper monitoring/supervision of heinous cases like vigorous persuasion of arrest of criminals in some murder cases/organized crimes have come to notice of CB. Your personal attention is drawn to few aspects viz

- 1. Previous conduct and C/A of criminals is vital piece of evidence vide Sec.8 of LE. Act. This will also help you in opposing bail to hardened criminals, if defended strongly & timely.
- 2. <u>Cancellation of bail</u>: As per section 437(3) and section 439(1)(a) Cr.P.C., accused persons can be enlarged on bail with specific conditions. For deliberate violation of bail conditions and for misusing the liberty granted to the accused, legal provisions are enjoined U/S 437(5) and 439(2) Cr.P.C. for cancellation of the bail. Thus it is imperative on the part of Dist. SsP/DCPs to move the concerned Court through the PP for cancellation of bail invoking the legal provisions U/S 437(5) and 439(2) Cr.P.C. To monitor this, each DPO must contain updated database of accd. persons (in heinous cases particularly) on weekly basis alongwith condition of bails. This must be put up to SP/DCP every Monday to have proper check & follow up action like cancellation of bail etc. in befitting cases on merit. For non-heinous cases, task may be delegated to SDPOs/ACP Zones.

A <u>Monthly Statement</u> should be submitted henceforth to CID, CB & CP/Range DIG/IG/ADG for reference stating action taken in the district in this regard every month.

3. Follow up action like pursuing execution of NBWs in organized crimes had been found to be wanting in one particular district leading to serious consequence on L/Q. This can be averted by updating database of Wanted Criminals at Range Level & Dist Level for specific pursuance of execution of NBWs/processes u/s 82/83 Cr.PC. Due to absence of database, this important aspect of crime monitoring is facing serious

setback. This can be checked by constant review of database at each DPO on monthly basis under direct supervision of SP/DCP concerned.

- 4. We had requested in this Office Letter no.147-153/ADG-Con dt.11.11.2017 to update Criminal Intelligence against fire-arm trade and concerned gangs. Unless specific task-oriented intelligence is insisted upon, this may not bear desired results to contain Crimes involving illegal fire-arms.
- 5. <u>Timely Supervision of SR Cases</u>:- While forwarding Report No-II, each SP/DCP is supposed to scrutinize FIR, 164 Statements, available evidence and offer his specific actionable comments alongwith S. Notes to strengthen the prosecution evidence etc. There has to be value additions at level of SP & Range DIG/IG as per prevalent age-old practice.
- 6. Few districts have shown ignorance about submission of F.F in Rape Cases within 60 days of FIRs as per Cr. Law Amendment Act,2018. Repeated advisories have been issued in this regard which is to be pursued/complied by SP/DCP.

I urge upon your personal supervision in these important aspects for effective handling of Crime Control & Detection/Prevention. Please submit your specific action taken reports for your district specifically (point wise) by 30.06.2019.
