Sub: **Steps to start activities to achieve transformational goal 'increasing conviction rate'.**

Sir,

In inviting a reference to the subject noted above, I am directed to say that that Government are planning to bring out 5T Chapter of Home Department containing transformational goals, each with activities and time frame.

It is requested to take necessary steps to start the following activities immediately to achieve the transformational goal 'increasing conviction rate'. Time frame is one year.

The D.G. & I.G. of Police, Odisha, Cuttack shall issue suitable instructions to all concerned on the following :

- To monitor important cases by State Crime Branch and appointment of Special Public Prosecutors in all such cases.
- Charge sheets to be filled as per the timeline prescribed and only in cases where proper evidence exists.
- Crime Branch to monitor trial of cases with respect to court appearance of witnesses, sending summons etc. to ensure improvement in documentation with regard to cases, scrutiny of Supervision Notes by Crime Branch to point out lacunae and ensure improvement in overall supervision of investigation of cases etc.
- SPs/ Range DIGs / IGs to notify important cases in the District and Range (50/100 respectively) for monitoring as notified by Crime Branch.
- Regular and sustained training of supervising Officers and Investigators to be organized both at State and Range level.
- To ensure timely examination of exhibits, proper packing of exhibits and timely submission before the Court.
- Work of Non-Cadre Prosecutors to be reviewed by the D.P.P and action to be taken against Prosecutors in acquittal Cases, as sent by District Level Standing Committee.
